SPECIAL COUNCIL MEETING

Mayor Grogan called the February 27, 2007 Special City Council meeting to order at 7:00 PM in Council Chambers at City Hall.

PLEDGE OF ALLEGIANCE

FIRST READINGS

Resolution 07-07: A Resolution Setting Forth a Buffer in the City Zoning Ordinance for Annexed Property Adjacent to Non-City Property that Presently has Township Zoning, and Declaring an Emergency.

Mrs. Cihon moved to suspend the rules on Resolution 07-07, seconded by Mr. Deans. **ROLL: Yes, ALL.** Mr. Colaianni moved for passage under suspension of the rules of Resolution 07-07, seconded by Mrs. Zahirsky. **ROLL: Yes, ALL.**

Resolution 08-07: A Resolution Indicating What Services the City of Canal Fulton, Ohio, Will Provide to the A.R. Lockhart Development Company, Immediately Upon Annexation, and Declaring an Emergency.

Mrs. Cihon moved to suspend the rules on Resolution 08-07, seconded by Mr. Deans. **ROLL: Yes, ALL.** Mrs. Cihon moved for passage of Resolution 08-07 under suspension of the rules, seconded by Mr. Colaianni. **ROLL: Yes, ALL.**

There was discussion on the flow of traffic from this area. Mr. Cozy stated it was intended to have traffic exit onto Cherry Street. He stated in the future the Stark County Engineer's plan to realign the Strausser/Cherry Street intersection.

Mr. Colaianni asked what the zoning would be inside the City. Mr. Cozy stated it would R-1 and that Mr. Belford would be presently this to the Planning Commission. Mayor Grogan reported that the Planning Commission has previously discussed this parcel.
